RELEASE INDEMNITY AGREEMENT FOR BATTLE OF FLOWERS PARADE 2012 CAVALCADE / CARRIAGE PARTICIPANTS

In consideration of the Battle of Flowers® Association's authorization of the undersigned to participate in the 2012 Battle of Flowers® Parade, the undersigned individually and/or as the authorized agent, representative, or supervisor of the participating entry whether it be one or more horses, mules, or other animal ridden by individual riders or animal-drawn carriages or wagons, hereby agrees to the following:

1. To read the Parade Rules and Regulations of the Battle of Flowers® Association as they pertain to this Parade section and by all the Parade Rules and Regulations of the Battle of Flowers® Association and abide by all the Parade Rules and Regulations of the Battle of Flowers® Association and fulfill all requirements set forth by this organization.
2. To release, indemnify, hold harmless, and defend the Battle of Flowers® Association, The Fiesta® San Antonio Commission, Inc., the City of San Antonio, their officers, directors, members, and past presidents from any liability, all demands, or legal actions (including third party actions and cross-actions) resulting from or regarding the above-referenced rider's, and/or animal's participation in the 2012 Battle of Flowers® Parade, including, but not limited to, death, injuries, and/or damages to person or property by any party, and all costs and legal fees incurred defending such demands or legal actions.
3. That an equine animal's reaction to sound, a sudden movement, or an unfamiliar object, person, or other animal is often unpredictable, but the horse or other participating animals are healthy and parade worthy, safe for rider and spectators, not unusually spirited and can be controlled along the Parade Route.
4. That each cavalcade rider is in good physical health and is not suffering from any condition which would impair his or her ability to participate in the 2012 Battle of Flowers® Parade.
5. Should the Battle of Flowers® Association decide that the undersigned's animal-drawn carriage or wagon needs to be towed off the Parade Route for any reason, the undersigned agrees to release the Battle of Flowers® Association, Southwest Parades, and Bill's Tractor from liability for any property damage to the animal-drawn carriage or wagon caused by the towing.

All participants must be twelve years or older. If the participant is under eighteen years of age, the parents and/or legal guardians also must sign this form, indicating their consent to their child's participation in the 2012 Battle of Flowers® Parade and agreement with each and every one of the provisions of this Release and Indemnity Agreement. Use the space provided on the back of this form for the signature of the parent/legal guardian.
