# Oratorical Contest

### 2021 CONTEST RULES REVISED JANUARY 8, 2021

**CONTEST DATE, TIME AND PLACE:** The Battle of Flowers® Association (“Association”) Oratorical Contest will be held on **Friday, February 26, 2021 virtually via Zoom due to the pandemic**. A live audience and judges will watch the contest at the Witte Museum located at 3801 Broadway, San Antonio, Texas 78209 in accordance with National, State and Local orders and rules regarding Covid in effect at the time of the contest. If rules preclude a live audience, the judges will use the Zoom platform remotely to judge.



**PRIZES:** The prize amounts our contest will award to 2021 winners are \$5,000 for first place, \$2,500 for second place, \$1,500 for third place, \$1,000 for fourth place and \$750 for fifth place. The top three winning students will earn their University Advisors a monetary award for the Advisor’s department: first place, \$2,500; second place \$1,500 and third place \$1,000. Other contestants who deliver their entire speech from memory will receive \$125.

**2021 CONTEST TOPIC:** **EXTRA! EXTRA! Texas Journalists Making History**

- Prospective contestants may choose and research only **one** of the suggested topics shown on the list of “Suggested Texas Journalist Making History Topics” in the Topic Description or may choose another topic **NOT** on the suggested list as long as it fits within the topic description.
- As in previous contests, the historical events/people commemorated **must have taken place or lived at least 50 years ago**. In this instance significant events and/or years of activity of the selected Texas journalist(s), journalist publication or production must occur prior to 1972.

**ELIGIBLE APPLICANTS:**

- Undergraduate or graduate students enrolled in a Texas university or college. An undergraduate applicant must be enrolled in at least 12 class hours and a graduate applicant in at least 6 class hours during the semester in which the contest takes place.
- The applicant must have an academic advisor from the university or college he/she attends. In extraordinary circumstances the selection committee can excuse this requirement.
- The total number of contestants selected to participate shall be limited to not more than twelve, and no more than three students from any one university or college may compete.
- Previous first place winners are not eligible to compete in subsequent contests. Other previous contestants may submit an application; however, since the contest can accommodate only a limited number of contestants, consideration will be given to how closely the contestant complied with contest rules and deadlines and whether he/she fully participated in all aspects of the previous contest.

**SPEECH AND JUDGING CRITERIA:** The Association expects a speech that is seamless, historical, impassioned and stimulating. Judging will be based on the content and presentation of the speech, which includes, but is not limited to, the following:

- **Content**

- adheres to the contest theme and remains on topic throughout
- appropriate for the intended audience of 500 at the Fiesta Luncheon primarily of educated, patriotic women and dignitaries
- is well-developed and clearly organized
- provides historically accurate information supported by research and references
- follows rules of grammar (e.g., word usage, pronunciation, sentence structure)
- must be original with an intent to inform and educate (not dramatic or comedic)
- Contestants are required to use and cite multiple sources from scholarly articles and books in the body of the delivered speech. All sources must be footnoted in the bibliography of the written speech. The speech will be submitted to plagiarism software examination.

- **Presentation**

- delivered completely from memory (no notes) from podium or standing in one location without a podium (if unavailable) and with a stationary microphone and camera
- no visual aids or costumes
- educates the audience by showcasing knowledge of the topic
- entertains the audience without being overly dramatic
- is not less than 10 nor more than 12 minutes in length  
The length of each speech should not be less than 10 or more than 12 minutes. Contestants who do not adhere to these time limits may have points deducted from their score or may be subject to disqualification. Timing by contest officials will start when the contestant begins to speak and the length of the speech will be reported to the Judges Chairman. A contestant may arrange for his or her own time prompter to be seated in the room and give only non-verbal prompts.

**ENTRY REQUIREMENTS:** To enter the contest, a completed entry form, along with a resume and a topical abstract must be received by the Contest Chairman no later than **11:59 PM. MONDAY, NOVEMBER 2, 2020**. Access the Entry Form at <https://form.jotform.com/202334623428046>.

- Topical Abstract: approximately 500 words in length and designed to give the selection committee a “snapshot” of the speech for the “EXTRA! EXTRA! Texas Journalists Making History” topic chosen, i.e., how applicant intends to show how the Texas journalist(s), journalist publication or production selected contributed to telling or participating in the story of Texas or to history, or impacted the course of Texas history or otherwise addresses the Contest Topic.
- Selection Criteria: Criteria utilized by the selection committee may include, but are not limited to, the following: adherence to the topic, clear development of the theme, suitability and interest to our audience, proper use of grammar, and historical accuracy supported by research.
- Applicants will be notified whether or not they have been selected as a contestant by **November 6, 2020**.

**APPLICANTS SELECTED TO BE CONTESTANTS:** For those applicants selected to be contestants, a written copy of their entire completed speech and bibliography must be submitted to the Contest Chairman **no later than 11:59 PM. Tuesday, January 26, 2021**. Failure to turn in the written speech by this deadline will result in disqualification of the contestant. Minor changes in the speech may still be made prior to the contest date.
